1. to establish, develop, promote and encourage CINVU among the OIC Member States in line and according to the STATUTE of CINVU;
2. to exchange academic members, researchers, experts and students for studying, teaching, conducting research or exchanging ideas in mutually interested fields of knowledge, science and technology;
3. to provide necessary facilities to exchange professors and scholars to spend their sabbatical leaves in the Members States;
4. to coordinate, cooperate and collaborate with each other for conducting joint scientific and technological exhibitions and conducting joint research projects;
5. to coordinate, cooperate and collaborate with each other for conducting joint scientific seminars, conferences, symposiums, workshops and training courses in cases of mutual interest and importance necessity;
6. to coordinate, cooperate and collaborate with each other to provide opportunities for professors, students and researchers to participate in conferences, symposia, seminar, workshops, masterclasses and other internationally defined sessions;
7. to establish an office of CINVU in the **VIRTUAL UNIVERSITY OF GABON (UNIVGA)** and preparing legal licenses for the official commencement of its activity;
8. to finance any of the activities and operations carried out by CINVU in line and in according the CINVU Statute;
9. to exchange information and documents of higher education system for evaluating higher education certificates and documents;
